Home Loan Program est. - 1921

California Dept. of Veterans Affairs est. - 1947



### Three Main Program Areas

- Veterans Services\Women & Minority Veterans
  - Outreach, education and benefits
- Veterans Homes of California
  - 8 long-term care facilities
- Home Loans Program
  - Home ownership benefit to qualified veterans





## California Veterans

### California Veterans

## Over 1.6 million veterans live in California, more than any other state.

- All military branches and all eras of services.
- 64% are age 55 and older
- 8.8% live below the poverty level
- 47% identify as an ethnic minority
- 10% identify as female



### California Veterans & Housing

- The majority of veteran households are considered economically burdened (spends more than 30% of income on housing related costs)\*
- Or severely burdened (spends more than 50% of income on housing related costs)\*
- More than 11,000 veterans are experiencing homelessness in California
- California is home to 25% of the nation's homeless veteran population and more than 50% of the nation's unsheltered homeless veteran population

# Veterans Housing and Homelessness Prevention (VHHP)

2015 - \$600 million bond authority from CalVet's Home Loan Program was secured to create the program.

Program administered by CalVet, HCD, and CalHFA.

Program components include:

- Competitive grant process
- Awards funding for the rehabilitation or construction of transitional, permanent supportive or affordable housing for veterans and their families
- Supportive services plan required in application process



# Veterans Housing and Homelessness Prevention (VHHP)

- Emphasis on veterans experiencing homelessness
- 50% of funding serves Extremely Low Income (ELI) and 60% of the ELI housing is Permanent Supportive Housing
- For every \$1 of VHHP money received, the awarded project leverages \$9 in other funding
- \$478.7 million awarded
- 3,058 VHHP units funded
- 5,664 total project units funded



### Veterans Support to Self Reliance (VSSR) Pilot

- Purpose: Provide enhanced supportive services for high-acuity senior veterans in permanent supportive housing. Demonstrate that aging veterans experiencing chronic homelessness can age in place successfully within permanent supportive housing.
- \$20 million total available in grant awards
- RFA scheduled for release in August 2022



# Women Veterans Affairs & Minority/Underrepresented Veterans Affairs

Specific connection to veterans and their families who identify as women, minorities, or LGBTQ:

- Outreach events
- Informational webinars, presentations, in-person events
- Advocacy for specific issues
- Referral and assistance

### Veterans Homes of California

Eight Homes in Barstow, Chula Vista, Fresno, Lancaster, Redding, Ventura, West Los Angeles, Yountville.

Levels of care:

Domiciliary (DOM)


Assisted Living (RCFE)

Intermediate Care (ICF)

Skilled Nursing (SNF)

Memory Care (MC)







### **Admissions Criteria**

- Aged, Disabled, or Homeless
- Military service active duty
- Discharged other than Dishonorable
- California resident
- Eligible for care by the U.S. Department of Veterans Affairs (VA)



## **Funding Sources**

- State General Fund
- Member fees
- VA per diem,
   other VA programs
- Insurance plans
- (Medicare, Medi-Cal, private insurance)


## VHC – Yountville Skilled Nursing Facility

- New, 240-bed Skilled Nursing and Memory Care
- Replaces the Holderman Hospital as the SNF, which opened in 1933
- Single-room occupancy
- Total project cost \$320 million
  - 65% of construction cost is covered by VA
- Projected completion 2024

## Home Loans Program



#### CalVet Home Loans

- Over 426,000 loans to veterans, since 1921
- CalVet is lender and servicer for the home loans
- NOT the Federal VA Loan Guaranty Program. Can be combined to achieve a "0" down payment lending solution
- The program has been administered at no cost to California taxpayers for the past 101 years



### CalVet Home Loans

#### Types of Approved Dwellings:

- Single family residences
- Condominiums/planned units
- Farms
- Mobile homes
- Housing in cooperative developments






### CalVet Home Loans - Specialties

- Construction Loans
  - With flexible draw schedules
  - No take out loans required
- Rehabilitation Loans
  - With flexible draw schedules
- Home Improvement Loans for current CalVet loan holders
  - Solar, new roof, health and safety improvements
- Insurance Benefits fire, earthquake and flood
  - Full replacement value
  - Low deductibles



## CalVet Home Loans: Who We Serve

- 18% of veterans earn less than \$50,000 per year
- 44% earn less than \$75,000 per year
- 64% earn less than \$100,000 per year






## CalVet Home Loans: Who We Serve

- Less than 7% are under 30 years old
- 20% of borrowers between 30 and 40

 Veterans over 60 years make up almost 40% of all borrowers
